


Kindergarten Immunizations:

Measles, Mumps, and Rubella (MMR) Trends in Pennsylvania

Every child should have health insurance and access to quality health care that is necessary for healthy development into adolescence and through adulthood. That care includes immunizations throughout childhood. Routine vaccinations for children are essential to keep them immune from life-threatening diseases before they are exposed. With the back-to-school season upon us, families should prioritize scheduling their children for well-child checkups so they are ready to learn.

MMR Vaccine Trends


For the second year in a row, the measles, mumps, and rubella (MMR) coverage rate for Pennsylvania kindergarteners fell below the 95% coverage target. Nearly 8,000 kindergarteners were not up to date on their MMR vaccines during the 2023-24 school year, a number that has doubled since the 2017-18 school year. This trend is not unique to Pennsylvania.

Around the country, decreasing rates of MMR vaccines have put some communities at high risk for a measles outbreak. The national MMR coverage among kindergartners is 93%. Only 11 states reported coverage levels at 95% or higher in 2023-24.

The MMR coverage rate also varies by county. Nearly two-thirds of Pennsylvania counties (44 counties) fell below 95%, with eight counties below 90% in 2023-24. The eight counties with the lowest coverage rates are: Bradford, Cameron, Dauphin, Fulton, Juniata, Pike, Snyder, and Wayne. Compared to five years ago, only eight counties fell below 95%, with only Dauphin County below 90%.

This report focuses on MMR vaccines given a resurgence of measles outbreaks across the country; unsurprisingly, other childhood vaccines for Pennsylvania kindergarteners are also trending downward, including ones that protect against whooping cough (94%), chickenpox (94%), polio (94%), and hepatitis B liver infection (95%). The larger health concern regarding fewer children vaccinated is increased risk of contracting preventable diseases that can lead to severe complications, long-term health problems, and even death.

Statewide Exemption Trends


In Pennsylvania, parents may exempt their children from immunizations for medical, religious, or strong moral/ethical reasons.^{III}

More than 6,100 kindergarteners (nearly 5% of students) were exempted in the 2023-24 school year. That's up from more than 3,400 kindergartners (nearly 3% of students) who were exempted in 2017-18.

Medical exemptions, which require a physician's signature, represent the smallest category and have remained relatively steady, accounting for 0.3% of students.

Philosophical exemptions have continued to increase in both size and percentage over the past several years, accounting for nearly 2% of students.

Religious exemptions are the largest category, which showed a steep increase starting in 2021-22. Exemptions for religious reasons now account for 2.5% of students.

PA Families Have Options for Affordable Health Insurance
