SCREENINGS PROVIDE A BRIDGE TO SERVICES

The early identification of delays in babies and toddlers and subsequent assessment and treatment ensure the best outcomes for these children as they grow. According to the American Academy of Pediatrics, "with as many as 1 in 4 children at risk for developmental delay, universal early childhood screening provides an opportunity to identify delays early and intervene during the most critical period of development."

"Early Intervention services focus on skills that babies and toddlers typically develop during the first three years of life but because of a developmental delay or disability the child is not meeting certain developmental benchmarks that may include cognitive difficulties, physical delays, and/or social/emotional, self-help, or communication skills that are not at age level," said Kimberly Engstrom, M.Ed., CARE Preschool Director and Early Intervention Special Instructor. "CARE wants to raise awareness that infancy through early childhood are the most critical learning years and community screenings provide an

avenue to address any concerns and connect families to services."

Developmental screenings are an important component in identifying children who may need services and also provide a snapshot of a child's development. Pediatric offices provide developmental monitoring by asking parents questions about their child's development. A missed milestone may signal a problem, triggering a more in-depth evaluation and possibly a referral to Early Intervention. Community screenings are an extension of that monitoring and provide an additional safety net for families. (continued on page 2- SCREENINGS)

Each fall CARE therapists provide a screening day for infants and toddlers at the Ashley Booth Griffin CARE for Children Center. These screenings are parent and child friendly and use evidence-based testing methods like the Ages and Stages Questionnaire. Parents are also provided other information on early childhood subjects like social-emotional development, early learning, dental health, safe sleep, and play and tummy time.

In certain instances screenings become imperative. According to the Center for Disease Control, "If a child is at higher risk for developmental problems due to preterm birth, low birthweight, environmental risks like lead exposure, or other factors, the child's healthcare provider may also discuss additional screenings. If a child has an existing long-lasting health problem or a diagnosed condition, the child should have developmental monitoring and screening in all areas of development, just like those without special healthcare needs."

CARE also participates each year in McKean County Kids Fest, the last Saturday in April, at the Bradford YMCA. During Kids Fest, El service coordination staff and local El providers offer a variety of screenings, including, gross and fine motor, social emotional, speech and language, vision and dental screenings.

"Families with young children should take advantage of community screenings. The good news: most families find out that their child is right on track developmentally," according to Cindy Wright, lead service coordinator for the McKean County Infant/Toddler Early Intervention Program. "If the family has a concern or one is found during the screening, it can be addressed immediately. Also, the agencies who participate in these events have lots of good, free information for families."

Wright also noted that each county has an Early Intervention office and parents can call and request a screening at any time. The McKean County Infant/Toddler Early Intervention office can be reached at 814-975-1221. Information for other counties can be found by calling the CONNECT Help Line at 1-800-692-7288. This is a nationwide hotline that can connect parents to their county Early Intervention office.

EDUCATIONAL IMPROVEMENT TAX CREDIT (EITC) PRE-KINDERGARTEN SCHOLARSHIP FUNDING

CARE for Children's Rainbow Corner Preschool is an approved Pre-Kindergarten Scholarship Organization through the Educational Improvement Tax Credit (EITC) program. The EITC program makes pre-Kindergarten scholarships available to eligible children and families. EITC contributions give local children the opportunity for a quality, early childhood education, while providing a tax benefit for participating businesses.

The program, administered by the Department of Community and Economic Development, enables eligible businesses who qualify through the State program and who make contributions to Pre-Kindergarten Scholarship Organizations, to receive a tax credit equal to 100 percent of the first \$10,000 contributed and up to 90 percent of the remaining amount contributed up to a maximum credit of \$200,000 annually.
